- A contribution to the National Development Fund of a minimum non-refundable amount of USD 230,000.
- The purchase of real estate with a minimum value of USD 300,000 from an approved real estate project. Two applicants can make a joint investment with each applicant investing a minimum of USD 300,000 in order to qualify. The real estate cannot be disposed of within the five-year period.

- **INITIAL APPLICATION AND SCREENING:**
