Citizenship By Investment

The Dominica offers a Citizenship by Investment Program which was established in 1993. The program allows the potential investors to acquire citizenship of Dominica and to work in any member state of the Commonwealth. The program offers several investment options, including a government donation, investment in real estate, or an approved business. In return for their investment, applicants receive the full rights and privileges of citizenship in Dominica, including the right to live, work, and study in any Commonwealth country.

Government Fund Contribution

Contributing to the government fund of Dominica offers a straightforward path to obtaining citizenship while actively participating in the country's development. The required investment amounts for dual citizenship through the government fund vary based on the number of applicants and dependents. The entry price for a single applicant is USD 200,000.

Real Estate Investment

Another option for investors is the real estate investment route, involving investment in approved projects like upscale hotels and resorts in Dominica's scenic locations. However, investors must retain ownership of the property for a minimum of three years. This option grants investors ownership of the property they invest in, with a minimum investment requirement of USD 220,000 for a single applicant.
